

## Using ChatGPT to Develop Teaching Materials: A Guide for Faculty

Artificial intelligence (AI) tools like ChatGPT can help you draft assignments, lecture outlines, case studies, and in-class activities. However, while tools like ChatGPT are helpful, they are only tools. Even the world’s best nails are useless without a hammer -- and without a person who knows how to swing it. Library research skills and a solid understanding of pedagogy are the hammers you’ll need as a faculty member in order to use ChatGPT effectively.

Whenever you use ChatGPT to help you outline or draft a journal article, you should include an explanation of how you used the tool, the prompts you used to generate output, and how you fact-checked the output. Documenting your use of ChatGPT to develop things like case studies, assignments, and lectures is more complicated because, unlike journal articles, those things rarely contain a methods section in which you could articulate the process used to conduct your research. In the absence of clear guidelines regarding how faculty members should document the use of ChatGPT in developing materials to use in teaching and assessing students, I would offer up the following:
