



Comments

I appreciated that a lot of the discussions in class were done in small groups as I am more comfortable sharing my ideas in this setting. The enthusiasm with which Kim lectured with made me want to pay attention to what she was saying and revived my interest in the subject.

Professor Kim always made sure to have an interactive section of the lecture which I found to be increase my own engagement. While sometimes it was tedious work, majority of the time I found subject and conversation topics to be interesting. Overall, her lecturing style was very inclusive and increased my knowledge of the topics.

The classroom discussions were where I learned most of the content from.

Class lectures and discussions greatly contributed to my learning in this course. I enjoyed the variety of ways this class was made to be interactive, in small, large, and whole group discussions. The use of the Jamboard was really interesting and useful in collaboration.

The way the class is structured is the type of way I like a class to be structured. First comes the lecture component where the slideshows are helpful for the factual information that I need to know. The big group discussions are also beneficial for me because I can see how my peers think and their opinions on a specific topic. I also enjoyed small group discussions because it was a way for the class to open themselves up more to each other while also practicing in real time the information that we learned.

Kim is an awesome professor and everything class there's something interesting that happens.

This course incorporated a great balance of lecture and small/large class discussions that allowed us to learn many different perspectives and opinions.

I think the group activities in class were particularly helpful, and I felt that the reflective assignments outside of class were some of the most helpful in the application of our learning.

The lectures and readings taught us the material in the syllabus, while the small and large group projects and discussions taught us how to apply the knowledge we learned.

I thought that the small group discussions helped me understand the topic more because I got to discuss with my peers.

The real time discussion and large group discussion promoted a great learning environment as we were able to hear diverse perspectives on health policy issues and topics.

Most of my learning occurred through whole course lecture, guided by the assigned readings. In addition, whole class discussion was utilized at the end of each class with frequent smaller group discussions occurring as well. Jamboards were used often to facilitate discussion and group activities.

Small and large group discussions helped me see other points of view when we were presented with a problem.
Kim does a great job of offering many modes for learning and demonstrating knowledge to keep us engaged, from JamBoards to small groups to lecture.
In person lecture really tied together the course objectives!
Kim does a great job of creating interesting small group activities that are engaging and applicable to the topic of the class lecture. She utilized real world examples in her discussions to make it more interesting and raw.
I liked small group discussions that gradually expanded in size till we reached a full class discussion. It made people feel more comfortable with their ideas and gained confidence in sharing.







Comments

Kim encouraged us to step out of our comfort zone and lean into conversations that could cause a real change. This is one of the very few nursing classes that I feel truly talked about racism in healthcare and in society in general. There were at times that I felt the tension in the air because the class felt uncomfortable with the conversation. However, I think that to truly have a meaningful conversation about race that we do have to acknowledge our own individual privileges. As a minority, I have been on the receiving end of racism, but that does not mean that I do not have privileges that other people do not. This is often a misperception and I feel like Kim encourage us all to acknowledge those privileges to allow us to reflect on how we see others and how others see us.

I mean like literally every day she made an effort to encourage dissenting opinions and she put a lot of work into making us know that everyone was respected.

Professor Kim was very open and upfront about people being respectful of other's opinions and diverse thinking. She acknowledged some of the barriers that some minority groups may face and she actively worked to dismantle those barriers within our class space. Never did I feel called out, or disrespected in her class. She is probably one of the realest and accepting professors I have had.

She never disagrees with anyones opinion, only hears us out and tries to understand where our opinions come from.

Kim is one of the best professors I've had at UVA in terms of respecting differences and welcoming diverse perspectives. She comes from a unique background of being quaker & part of the LGBTQ community, and this certainly helps in her acceptance of others ideas. We certainly brought up controversial topics in regards to health policy, but did so in a respectful and inquisitive manner. We also were put in small groups on perspectives that may have been different than our own (ex. supporting decriminalization of marijuana vs. not decriminalizing marijuana federally), causing us to challenge our own viewpoints and learn about oppositions. Sharing out what we'd learned in small groups was always really productive and interesting— I was able to learn a lot from Kim and others in the class in doing this.

Kimberly said on the very first day of class that she fosters an environment where she accepts and wants people from all different

kinds of backgrounds and opinions. She said she welcomes them because it is the only way that students get to see both perspectives. She creates a safe space for students to express their opinions and also does not judge anyone based on those values.
Topics that we discuss in this class is a diverse topic and can be sensitive to some people, but Kim did a fantastic job in respecting everyone's idea and provide a safe and equal environment for everyone in the class
She made sure that everyone felt comfortable and supported. She created an environment where people felt safe sharing their experiences.
She always made sure to welcome and offer multiple perspectives. One that stands out is one of our first class activities regarding the political spectrum and allowing us to see how broad the spectrum of political ideologies is in class while maintaining anonymity. I think she set up the tone of the class to be respectful and open to the many diverse perspective of health policy and of the student body.
She established a respectful class environment during the very first class and diverse perspectives was a core value of her teaching.
Professor Acquaviva always made me feel welcome in her class and I really appreciated that she gave me personalized feedback on my assignments because I could tell she read them and appreciated my hard work.
Professor Acquaviva made it clear all viewpoints and opinions were welcomed in the classroom.
Kim encouraged us to have discussions that promoted diverse perspectives, even if it might lead to a degree of discomfort as they were important conversations to have in regards to promoting equity and equality in healthcare.
Kim is a fantastic professor. She creates a classroom environment where everyone feels comfortable speaking up, asking questions and participating. She values all opinions and makes sure her students know that. In addition, she is flexible and understands that her students have other classes and other things going on in their lives. She adapts the class to what the students need!
Health policy is a tough topic to teach a group of students who may not share opinions about the topics. Kim did a great job of presenting the information objectively, repeatedly saying that just because she makes a statement, it doesn't mean that she supports that point of view
The first day of class ground rules JamBoard; being an ally and facilitating dialogues about structural racism.
Professor Acquaviva encouraged students to give their perspective on a topic even if they conflicted with someone else. She was encouraging and made sure voices were heard in a respectful manner.
Kim was always welcoming of different opinions and opened up the floor for people to challenge her thoughts! She used inclusive language and established a safe space for all students. She was also inclusive of different learning styles and never judged students if they chose not to talk as much.
She is just the best. She herself leads the class with honesty and isn't afraid to read the room and not shy away from the ugly.
Professor Acquaviva encouraged us to have diverse perspectives! Through this class I learned how to communicate and possible persuade people with differing perspectives from my own. The class discussion always provided room for alternative viewpoints and each person's contributions were valued.
Every class, Kim encourages everyone to speak up about their opinion and is always so excited to listen to our perspectives and honest opinions. I have never had a class where the professor has been so open to any type of response as long as it was not harmful to our classmates.
Actively brought up systemic inequalities and racism in discussion and lectures
It was made very clear at the beginning of the class that we all have different perspectives and attitudes about things and that unless the thought was hurtful, it was a valued perspective.
Kim is probably the most respectful and thoughtful professor that I have ever had at UVA – she is constantly thinking about how to make everyone feel comfortable and heard in her class. She is also encouraging of everyone to share their opinions (no matter how they differ) and to try new things like facilitating discussions.
From the beginning she stated how this was a safe place welcoming different opinions and did a great job stating expectations on how it was not an argumentative class but instead a place to learn from different people.
She wanted us to feel comfortable to express our opinions, she respected the fact that we all come from different backgrounds and that we may have differing viewpoints and not to shy away from saying them. She wanted to make it such that we all felt heard and understood.

Kim goes above and beyond to hear all perspectives and to set up the classroom as a respectful environment.

She always encouraged everyone to be inclusive of others in the classroom – a specific example is that when someone would lead class discussion she asked them to use the mic in case there were any people in the classroom that are hard of hearing.

From day one, she did it so well – better than any other professor I've ever had. She made a point to start this conversation and make every opinion and voice feel heard from the start of class. She also never assumed one side was right, though she did

sometimes give her own opinion on things.

This class has to be the most welcoming environment I have had on Grounds. Kim does an excellent job making everyone's voices heard and validated. In the beginning of the semester, we had a whole class discussion about the expectations on the classroom environment, which I found incredibly helpful. Furthermore, Kim and my peers created an environment of respect to all backgrounds and there were many opportunities to learn from each other during the semester.

She acknowledged the uncomfortable topics that most people don't want to talk about, and this opened the floor for anyone to chime in with their thoughts as well

Always encouraged representation from minority groups and encouraged discussion around difficult subjects. Always discussed policy's relationship with minority groups and the impact that different policies had on different communities

She is very respectful and is understanding to different viewpoints

No matter your stance on something, Professor Acquaviva wants to hear it all. She cultivates an environment where her students feel safe to talk about potentially controversial/ hard subjects, and she makes everyone feel heard.

She constantly encouraged all sorts of opinions and never gave someone a hard time for saying something that was maybe a less popular opinion. She herself would offer a different perspective on topics to help us understand how other people may interpret a problem completely different than how another person might.

When talking about difficult topics such as racism, Kim always made sure to provide an open space for dialogue, encouraging those of all views to share their thoughts.

She was clear at the beginning of the semester that she really valued other perspectives/ideas, and that it often adds to the class rather than takes away from it. She set realistic boundaries on what was appropriate to discuss, and she did a great job of keeping in mind students of color who are often disproportionately affected by policy. We had many discussions on racism, discrimination, and privilege in the class, and reminded us of our job as future nurses to be leaders of change. She never shot down ideas from students, and was incredibly welcoming to everyone.

The course offered regular open discussion in which all opinions were welcome. Students willing to participate, were equally listened to and understood by the professor and fellow students.

always encouraged us to respect and welcome new ideas, regardless of what the opinion is and who is giving it. allowed this class to be a voice for those who are often underheard and looked over

She welcomed everyone's comments and made it known multiple times that her class was a safe space.

She set the expectation at then beginning of the semester that all opinions were welcomed as long as they were said in a respectful manner.

From day one, Professor Acquaviva established an environment that respected differences and welcomed all perspectives. Even though she made a great effort to establish this environment, I still did not speak up as much because of the fear of what my classmates would think; however, I know that Professor Acquaviva would have respected such a different or diverse perspective.

Kim always asked for thoughts and opinions, and she understood and welcomed the opinions shared by minorities in the class

Jamboard at the beginning of class and talking about how it's okay to have different perspectives and to also understand that everyone comes from a different background.

SOme topics were political or controversial and she welcomed all questions and comments from students.

She laid out at the very beginning of the semester that all perspectives were welcome, with the exception of hateful ones. This addressed the elephant in the room early on and allowed us to move forward with discussions.

Kim always encouraged us to share out opinions, even if they are not popular.

We created a safe and accepting space on the first day of class. That was extremely important and we felt the effects of that throughout the several weeks we were in class.

We had lots of conversations and were able to express our own opinions in a way that we could learn and grow

I never felt so comfortable and welcomed to be present until this course. As a mintority, this speaks volumes.

Kim is the best professor at creating a safe, respectful environment that welcomes diverse perspectives and individuals. This class welcomed tough conversations and encouraged everyone to share their thoughts. She established class guidelines and led by example on how to respect everyone and their opinions. She acknowledged all responses and feedback in a respectful manner.

Kim created an environment that respected differences by communicating to the class that different perspectives and opinions were welcomed and set ground rules that we would all respect our classmates by active listening and discuss policy rather than politics

Kim is an amazing professor. She is always open to student feedback, encourages whole–class discussions, and makes everyone feel welcome in the classroom.

She repeatedly told us how important it is to listen to all different perspectives

The very first day of class she made it known that everyone had a space in her classroom and all opinions were welcomed besides those that were harmful to others.

From the first day of class, she made it clear that she recognized her privilege and that her perspective was influenced by it. She also created an environment in which all feelings (except for hate/disrespect directed at one another) were welcome and could be expressed.

She allowed for class discussions to be open to every and all perspectives on topics.

Kimberly allowed all opinions to be shared, and even discouraged opposing views to speak up to create a thoughtful discussion.

Kim made it clear from the first class that this class was a safe environment to express our differences and diverse perspectives. She is one of the few professors that made this explicitly clear from the beginning. This is crucial for the nature of the class and Kim did a great job facilitating complex discussion and respecting multiple viewpoints.

Everyone's opinion is welcome and not looked down on.

Kimberly Acquaviva instituted assignments that welcomed and encouraged differing opinions while also fostering an environment that allowed for respectful and meaningful discussions to be had.

She was very inclusive

She was very direct about the fact that although the class surrounded policy, she assured us that differing perspectives were absolutely welcome and crucial to have to create engaging class discussion.

During syllabus week, Kim created a foundation for our learning environment that welcomed diverse opinions. I remember that we had to do an activity where we had to log into a collaborative JamBoard — the JamBoard had different types of political standings (i.e. Conservative vs. Liberal) and we had to anonymously place ourselves in the standing that we best identified with. Of course, there was a wide range — some people were very left leaning, while others were very right leaning, and many people were somewhere in the middle. Despite this, Kim validated everyone's standing and did not make people feel ashamed for their placement. This created a foundation where everyone could feel safe to speak out during discussions for the rest of the semester.

Always made people feel comfortable to talk. Never made anyone feel uncomfortable.

From the very beginning of the class, she openly stated that she welcomed all viewpoints and that anyone can speak up for what they believe in without judgement.

She was very open to all opinions, but also made me as a Black student feel heard, understood, and respected in her classroom. More than any other classroom I have been in.

What constructive suggestions do you have to help Kimberly Acquaviva improve this course for future students?

Comments

I really appreciated how you took in consideration our opinions throughout the course. I

Incorporate more applicable and real life journal articles towards the end of the semester. I feel like the beginning of the semester had a lot of articles pertaining to the topics we discussed in class and they were really interesting and engaging. After about the midway point the readings began to dwindle to just textbook readings and I felt less inclined to read those.

Instead of writing a advocacy paper it would be more constructive and fun to do an advocacy activity in groups-like a field trip or something else.

This is a wonderful six week course, thank you for the way you've treated our class like adults! I would continue to make things even more interactive, as well as explain health policy basics (ex. who are stakeholders) in an understandable way for people who know nothing about it. I also am curious how the class dynamic would change if it was in two smaller sections or included only nursing students?

Honestly I have no suggestions. The way she presents the class and the curriculum is amazing

There were certain changes that Kim made this semester and I think summarizing the readings can be extremely helpful and is something that maybe future classes can be benefited on.

The only suggestion I have is that sometimes the powerpoints (mostly in the beginning) were very wordy and could be hard to follow. I think she does a great job lecturing, so all of the information we need comes from her and the powerpoints can be made to seem less overwhelming.

I think the class group activities were the most helpful in reinforcing my learning, I think having more class activities for more lectures could be helpful!

I really valued the small group discussions over the large group discussions. For me, they were much more productive and meaningful. I didn't participate much in the large group discussions because it felt hard to share something personal and vulnerable in the particular classroom setting we were in (rows where when I was sitting near the front I couldn't see most of the class while I was talking). Small group discussions about serious topics were much more meaningful for me.

I think that Professor Acquaviva did a great job and I liked how the course was ran as is!

Professor Acquaviva prefaced the class by sharing that all viewpoints were welcome (Liberal, Conservative, etc.) However, I felt, as a Conservative leaning student, unable to share my opinions in fear I would be cancelled or labeled a racist. My only suggestion would be that Professor Acquaviva bring up the Conservative view points of issues to "play advocate" as well as educate students about different sides to the problem.

Keep doing what you are doing! Being tolerant, flexible and kind!

I know this isn't possible due to the structure of 4th year nursing student clinicals, but I wish this class was shorter and lasted an entire semester. It is really hard for me to focus for 3 hours

Maybe more clear and concrete expectations for the deliverables of each class, rather than just how the class would meet the course objectives (which felt very abstract). Knowing what to prepare for more concretely would increase my engagement, personally. And possibly more opportunities for reflective writing.

I ended up thoroughly enjoying this class! I appreciated that you treated us as adults and equals in conversation and had clear expectations, while also being really flexible. Occasionally, class seemed to be all lecture over the three hours. However, I know we had a lot to cover! On days like this I would suggest two shorter breaks as opposed to one long one. Thanks for a great 6 weeks!

More small group activities!

Summarzations of readings for those who want to read, but whose life gets in the way.

Sometimes the didactic portions of the lecture were really difficult to pay attention to. I dont know if there are other ways to relay this information, but it might be helpful to break it up more. Additionally, we often ended class on a high tension point where the Professor would deliver some kind of monologue on a controversial issue like racism. Although I understood the intent, this often felt ineffective. Perhaps it would be better to have that discussion in the middle of class so we could debrief and talk about it rather than just have class disperse immediately after.

If there are any videos, interviews, clips from documentaries about health policy, I think that would be a great addition and something interesting (a break from lecture and discussions occasionally).

Different writing assignments- some that are more focused on health policy than on racism.

I would like for less classes to end in a dejecting way... often we would discuss huge injustices and inequities in health care and the brokenness of the system seemed overwhelming. I think it would be beneficial to end those discussions with, as a class, coming up with a handful of small things we could do to contribute to a healthier system and be antiracist in the healthcare field. That way we end class with a few practical action steps and it feels less hopeless.

I would spend less time lecturing to the class and more time watching videos or other media sources that demonstrated the topics being learned

I know this is out of your control but my only complaint about this class was the time. It was hard to stay motivated to go to class at 2pm

I don't have many suggestions, except I think it could be helpful to discuss the advocacy assignment reactions as a class or in small groups. I think this could benefit the class, but some may be uncomfortable, so possibly taking a poll of interest in this could be a solution

A guest speaker at some point in the semester may further aid learning and offer an additional engaging discussion.

I like how we were given a lot of autonomy for different discussions, and we were given a lot of options for how we wanted class to go on certain days. But sometimes I do wish that we were just told what to do. I think most students can be pretty apathetic and not have strong opinions for how they want things to go — they just want to be told what to do and get it done. Sometimes being given choices just slowed the class down as there would be a lull due to students not really have a strong opinion for things if that makes sense.

More videos... I feel like there are so many powerful visuals out there that could help bring policy change to the classroom.

I think this class was one of my favorites at UVA. With the small group and full class discussions, it really made everyone be engaged. I also feel like with there being no exams, it made me pay attention more without stressing about taking notes and thinking about exams. The attendance and late work policy were also great because it is stressful having to worry about going to class if you are not feeling well or turning in an assignment when there are other circumstances that you don't feel like disclosing, so I thought they were very helpful.
